GENERAL INFORMATION

STIPEND - Consolidated Rs.15000/- p.m. In addition to Stipend, Medical Scheme facility (for self only) under its Contributory Health Service Scheme, free transport facility and subsidized Canteen facilities are admissible for the above post.

Age Limit: 30 years. Age relaxation is admissible to SC/ST/OBC/PH/Ex-servicemen candidates, etc. as per Government of India orders on the subject.

Only Indian Nationals need to apply. The number of vacancies indicated above may be increased / decreased depending on the actual requirement of the organisation. The above post is purely temporary for a period of one year only.

The eligibility criteria with regard to age, qualification, experience, etc. shall be determined as on 11/10/2017.

Candidates fulfilling the eligibility criteria (Qualification, Percentage, and Year of Passing as mentioned in the advertisement) will be shortlisted for further screening process. Merit list will be prepared from the list of candidates fulfilling the eligibility criteria based on the percentage of marks.
