#### 1. Invitation for Submission of Expression of Interest (EOI)

### 2. Brief Introduction & Scope of Work

#### 3. General information related to the event

- ✓ Event/Banquet Managers having professional qualification in Hotel Management and experience to handle work in similar set ups must always be available throughout the event for effective control and supervision of his staff and for any other requirement. Adequate staff to be deployed.
- ✓ High standard of cleanliness, good hygienic sense of staff is the basic requirement of the event. Promptness in service shall be ensured at all times.
- ✓ The persons deployed to work, should be above 18 years of age, perfectly fit, with ability to communicate in English. They should be well trained, mannered and experienced. The entire F & B staff should be in perfect uniform and hygiene wears and free from any disease. The wearing of food quality hand glows and head gear during service is a must. The contractor or his manager shall have to remain available throughout the event for effective supervision.
- ✓ The ODC caterer will be responsible for all security and safety, including fire safety aspects of the entire banquet.
- ✓ This Expression of Interest is for Outdoor Catering Services from firm/s who fulfill the **Eligibility** criteria and submit proposal.
- ✓ The numbers of pax mentioned here are indicative.
- ✓ The Expression of Interest shall be sealed in an envelope super scribing "Expression of Interest Outdoor Catering Service at Sabarmati Riverfront Event Ground, Ahmedabad". The EOI should invariably have a **suggested** menu from welcome drink to dessert including tea/coffee. Menu should be a mix of Veg and Non veg. for the event.
