- 1. As it is qualitative decision, an evaluation committee will decide the group. Performance Videos should be submitted in the DVD for evaluation.
- 2. Evaluation will be done on the basis of selection of variety of classical music of different parts of India.
- 3. Evaluation committee members' decision will be final.

#### 4. General information related to the event

- 1) The bidder shall be required to provide excellent quality of performance considering selection of variety of classical music of different parts of India under the EOI.
- <sup>2)</sup> The coordinator shall have to remain available throughout the event for effective supervision.
