NOTICE FOR EMPANELMENT OF CONTRACTORS FOR CIVIL & ELECTRICAL WORKS

Notice No.: IPR/EMP/2010

The Institute for Plasma Research (IPR), situated at Bhat Village, Nr. Indira Bridge, Gandhinagar, is an autonomous premier scientific research Institute under the Department of Atomic Energy. The Institute wishes to empanel contractors for Civil & Electrical Works, each of the value up to ₹ **25.00 Lakhs** for a period of 3 years.

Reputed and interested contractors may collect a prescribed form for empanelment from the Head, Civil Maintenance Group's office at the above address **on or before 29.10.2010 between 10.00 hrs to 12.00 hrs and 14.00 hrs to 16.00 hrs** on working days (Monday to Friday).

The application in the prescribed form along with all supporting documents in sealed envelope super scribing the notice no., date and "Application for Empanelment for Civil/ Electrical work (whichever is applicable)" should reach the Head, Civil Maintenance/ Electrical Group's Office, IPR **on or before 17.00 hrs on 15.11.2010**.

The critical qualifying criteria for empanelment is as follows:

1. Should have Valid Registration in Appropriate Class Registered or working with CPWD/PWD/SAC/MES/RLYS/Other Government/Statutory Bodies
2. Should have valid Bank Solvency of minimum ₹ 4,00,000/-
3. Should have carried out atleast two works of value greater than ₹ 10.00 lakh during last 3 financial years
4. Should have valid Electrical Contractor's license for Electrical Works

The Contractors who are found eligible for empanelment by the Institute, will have to deposit an amount of ₹ 50,000/- in the form of Fixed Deposit/Demand Draft/Pay Order from Nationalised/Scheduled Bank till the validity of empanelment. The amount so deposited will be considered towards the Earnest Money Deposit for the tender enquiries that shall be issued to the Contractors after empanelment.

The Director, IPR reserves the right to accept/reject the Application for Empanelment or to cancel the notice in toto without assigning any reason thereof.
